



Contractor Membership Application

We appreciated your interest in becoming a Contractor Member in the Alabama Asphalt Pavement Association. Please review the following information, if you have any questions please contact the Association.

The Membership is comprised of the leading asphalt pavement contractors (19), liquid asphalt suppliers (5), aggregate producers (5) and other industry associates members (52). The Association office is located in Montgomery, and the staff is comprised of an Executive Director and an Administrative Assistant. The office staff complies and disseminates information relative to the industry and promotes the use of asphalt through research and development, technology transfer, quality improvement and public relations.

The dues structure for Contract Membership is as follows:

- A. Asphalt Producer/Contractor - \$5000.00 for the 1st plant and \$1000.00 per additional facility.
- B. Tonnage produced and reported @ 0.15% per ton.

Plant dues are payable January 1 of each year. Tonnage dues payable by the 15th of each month.

The Association offers many services to its members:

*Center of Information – Publish a newsletter, membership roster and periodic bulletins to bring members timely and useful business and technical information; source of pavement design information, AAPA's Asphalt Pavement Design Guide.

*Marketing/Education – Prepare and distribute promotional and technical materials to users and specifies pointing out advantages of our product; arrange conferences, seminars, other meetings to inform, educate and update these same people and our members.

*Governmental Relations – Monitor the activities of the State Legislature and represent the interest of our industry, keeping the lawmakers and regulators informed so their actions are not a result of lack of information; maintain close relationships with public agencies and represent the industry before various regulatory bodies.

*Public Relations – Provide a medium through which all members can speak as an industry when group actions is necessary; build good will for the industry to expand existing markets and enhance the importance and image of the industry; maintain close liaison and cooperative relationships with other state and national associations.
